In the framework provided by Article 51 of the Regulation (*EU*) **2016**/794 on Europol, we are pleased to invite you to the **10th Meeting of the Joint Parliamentary Scrutiny Group** (**JPSG**) on the European Union Agency for Law Enforcement Cooperation (Europol). The Meeting will be hosted by the *Assemblée nationale* of France in Paris, and will take place on **28 February 2022.**

Due to the continuing measures related to the Covid-19 pandemic, the meeting will take place via remote participation.

The Meeting will have on its agenda a number of specific issues directly arising from the JPSG's prerogatives according to Article 51 of the Europol Regulation, including presentations by Catherine DE BOLLE, Executive Director of Europol, and Mr Wojciech WIEWIÓROWSKI, the European Data Protection Supervisor. Keynote interventions will be delivered by Ylva JOHANSSON, EU Commissioner for Home Affairs, and Gérald DARMANIN, French Minister of the Interior. The thematic debates will focus on the opportunities and risks of Artificial Intelligence for Europol, and, Europol's contribution in the fight against migrant smuggling.
