

Health notice

Interparliamentary Conference on the strategic economic autonomy of the European Union

Venue : Senate Date : 13-14 March 2022





This note details the health measures in force at the time of the meetings in the Senate.

It should be noted that the sanitary regulations applicable in France will be modified as of the morning of March 14. Therefore, the same health instructions will not apply for the official dinner on March 13 and the conferences on March 14.

All participants in the March 13 and 14 meetings, regardless of their vaccination status, are strongly encouraged to have a PCR test done before leaving for France. Otherwise, it is strongly recommended to get tested in a pharmacy (list of pharmacies near the hotels down below), before the meetings in the Senate.

Health measures in force on March 13

- A valid EU digital COVID certificate is needed to access the French Senate. Otherwise, members of the delegations will be asked to provide the negative test result of a PCR or antigen test less than 24 hours old.
- A test will not be systematically administered upon access to the Senate. However, participants will be able to get an antigenic test at the Senate, notably in case of issue with the EU digital COVID certificate. If the test administered at the entrance of the Senate is positive, access to the Senate will be denied.
- A face mask (covering the nose, mouth and chin) must be worn on all Senate premises including outside buildings.
- Please wash your hands regularly with soap and water or hand sanitizer, if water and soap are not available. Hand sanitizer dispensers are available at the entrance of all meeting rooms and inside the main halls and corridors of the Senate. High touch points are regularly disinfected by Senate clerks.
- Please be mindful at all times of social distancing rules. Please enter the hemicycle and other meeting rooms in a staggered manner. Inside elevators, please avoid standing face to face with others and maintain a one meter distance between two people.
- At the end of meetings, please exit the room in a staggered manner or follow the instructions that may be given orally.
- Within the Senate, dedicated trash cans are available for COVID-19 waste (masks, wipes,...). Please dispose of used masks in these trash cans.
- To reduce the risk of transmission of COVID-19 we kindly ask to also keep the advised safety distance during potential coffee breaks. Formal diners will be offered, with participants seating at least one meter apart.



Health measures in force on March 14

- Wearing a mask (covering the nose, mouth and chin) is no longer mandatory, but remains possible throughout the Senate.

- It is recommended to wash your hands frequently with soap and water or, failing that, with hydro-alcoholic gel. Dispensers of hydro-alcoholic gel are available at the entrance of each room and in the main access and circulation points of the Senate. Regular disinfection of the main points of contact is ensured by the Senate staff.

- Please be mindful at all times of social distancing rules. Please enter the hemicycle and other meeting rooms in a staggered manner. Inside elevators, please avoid standing face to face with others and maintain a one meter distance between two people.

- At the end of the meetings, please leave the room in a staggered manner, respecting the instructions that may be given orally.

- Within the Senate, dedicated trash cans are available for COVID-19 waste (masks, wipes). Please dispose of used masks in these trash cans.

- To reduce the risk of transmission of COVID-19, a strict respect of safety distances is expected during coffee breaks.

- Seated meals require a minimum safety distance of one meter between each person.
